NEW FEATURE – PHOTO LINEUP


IA-56326: Photo Lineup Module

The Photo Lineup is a *new module* within Online RMS that will allow users to *create, save, and edit photo lineups* for persons. The photo lineup module is available as a *standard product capability* to agencies and users that have full subscription access to the Online RMS. The module has been *enabled for all agencies* for *initial deployment*. Please contact Caliber Support if you *Do Not* desire this feature be enabled for your agency. In conjunction with this new module, person images were also enhanced to support selection of the *person image type* (*Mugshot, DL Photo*, etc.) as well as the capability to mark an image as the *primary display image* for a person. The person image type supports a configuration option to indicate if a person image type should be available for use in the photo lineup module.

Access to create, edit, view, or delete a photo lineup is controlled via role permission categories. Additionally, there are maintenance configurations to support the number of images allowed for a lineup and default +/- range parameters for person height, weight, and age.


The photo lineup can be *accessed* from the following areas within the Online RMS:

1) Create a photo lineup from Records Management Menu





2) Create a photo lineup from View and Edit Person pages




3) Create a photo lineu from *Involved Names and Organizations* grid in the *Follow-up Case Management* module




A **sample workflow** for creating a photo lineup from a Master Person page will be reviewed to provide an overview of the photo lineup capabilities. Please take the opportunity to review this new module in your **training system** or contact Caliber Support if training is desired.

- > **Search** and **select** a person from the master name index that has a **person photo**. If the person does not have a photo, select to add a person photo.
- > Select the *Create Photo Lineup* button






Confirm the creation of the photo lineup for the person





- The primary person photo displays under the **Suspect tile window** on the left side of the page. The left side tile window can be expanded by **clicking on the edge** with the mouse pointer and dragging to the right.
- Enter a *name* for the photo lineup
- Click on the Suspect Physical Description drop down menu to select the physical description information for the person image to use for searching and finding similar images. The default +/- range parameters for person height, weight, and age will automatically populate.
- Add, Subtract, or Modify the search parameters as desired. The max number of photos for the search results can be adjusted as needed.




Search to find matching photos from persons entered in the Online RMS that have person images






> Double click to select and add comparison photos to your lineup.




- ➤ If you are unable, to locate suitable comparison photos to include in the lineup from images in the master person file in the Online RMS, a feature was added to the *Lineup module* to allow users to *load comparison images from their computer or local / network drive*.
- Click on the Upload Images tab, Add Files, and select to add one or more comparable images





Imported image files will be automatically added to the lineup and also saved in the *users Uploaded Image Library* tab for future use. Images can be deleted from the Image Library by the user as needed.




When all images have been selected, click the **Print** button to print the photo lineup





Users can choose to print one image per page, include a signature line on last page, and a lineup image key. By default the print option will print all images on one page unless the option to print One Image Per Page is selected.



> Example of one page print for all images








Once satisfied the Lineup is complete, click on the *Complete* button to finalize. The *finalize* function will check to make sure the number of images matches the number of photos (*photo count*) configured for your agency. Once completed, the lineup can only be modified by the creator of the lineup or agency admins having the appropriate role permission to edit.





Showing 1 to 2 of 2 entries

- The photo lineup can be **searched**, **viewed**, **and printed** from the **Records Management** menu.
- The photo lineup includes an **Access Log** that tracks who viewed the lineup, who printed the lineup, and once finalized, who edited the lineup. The **Access Log** is viewable from the **View Photo Lineup** page and the **Edit Photo Lineup** page.






Authorized users with granted permissions have access to **delete** a photo lineup. A record of deleted lineup is maintained in the **Delete Log** which is viewable for users with appropriate permissions from the photo lineup search page.



RMS CHART ENHANCEMENTS

IA-59787: Enhance Home Page Non-Approved Reports to Focus on Original Incident Only


Supervisory users will notice that the *Non-Approved Reports pie-chart* on the home page has been enhanced to *only* display counts for *Initial Incident Reports* (Supp 0). Counts for other report supplements (Supp 1 - ###) can be viewed via the *Unapproved Incidents* link under the right hand Charts grid. This enhancement will allow supervisory staff to better focus on the status *Initial Incident Reports* (Supp 0) to ensure they are completed in a timely manner.





IA-59789: Enhance RMS Charts - Unapproved Incidents - Include Filter for Supp #0 only

Supervisory users will notice that the *Unapproved Incidents* dynamic chart available via the right hand chart grid has been enhanced to default the display to *Initial Incident Reports* (Supp 0) only. User can select the new Supplement Filter drop down menu to select to view counts for all Incident Report Supplements. This enhancement will allow supervisory staff to better focus on the status *Initial Incident Reports* (Supp 0) to ensure they are completed in a timely manner.






SEARCH ENHANCEMENTS

IA-59468: Enhance the One line address search to improve the relevance of the search results

The *one line master address search* field was modified to reduce the number of search returns by *removing city, state, zip code, county, and country* from the master address one line search index. When needing to search by city, state, zip code, county, or country, you must use the individual address search fields. Additionally, wild cards were removed and the search will use the search terms in the order as they are typed in the one line address search field.

As Example; "10 Main Avenue" will return addresses having the words 10, followed by Main, followed by Avenue. There can be any number of words in between the search terms.

At this time, the search **Does Not** include synonym searches for **direction** and **street type abbreviations**. It is recommended that **direction and street types** not be included in the one line search terms or if needed, to include the **full description of the terms**, such as 'South', 'North', 'Street', 'Road'. The capability to handle direction and street type abbreviations will be implemented in the next release using synonyms.









IA-57656: Citations - Use New Quick Search

Users having access to enter citations in the Online RMS will notice that quick search options for Persons, Vehicles, and Locations have been added to the Add and Edit Citation pages. These quick entry search options are aimed at improving usability and to streamline manual entry of citation data into the Online RMS.








IA-59480: Field Contact - Add ability to search by Custom Fields

The capability to search by *Custom Fields* added to a *Field Contact* is now available for agencies that have custom fields enabled to capture data when entering a Field Contact. Users can select *one or more Custom Fields* for *searching* of Field Contacts.






ADMINISTRATION ENHANCEMENTS

IA-59361: Set Display modules for Charge Codes and Arrest Charge Codes

An administrative configuration enhancement was implemented to allow sites to **select the modules** where a specific **Charge Code** should **display**. When editing or adding a new Charge Code an administrative user now has the capability to specify whether the charge code can be selected in the **Field Arrest, Citations, or Warrants** modules. Selecting no modules will cause the Charge Code to display for all the modules. This enhancement will benefit agencies that do not want non-criminal traffic violations or other charges required for citations or warrants to appear in the Field Arrest charges section.





IA-60049: Expire Temp Passwords

To stay consistent with *industry best practices*, the following security enhancements were implemented when resetting a password via the email option:


- Provide a *onetime* user specific *link* for the user to click on to reset their password
- Expire the link after XX minutes if the password had not been reset by the user. The default expiration time period has been set to 60 minutes for all sites.

This new security enhancement will apply when:

1) A user selects to reset their password via the email link that displays after the user selects the Reset Password link on the *Login* page.





2) An agency admin selects the option on the *Manage User Page* to *Reset Via Email*. This option will send an email link to the user to reset their password. The link will expire if not acted on before the expiry time limit (system default of 60 minutes).





3) A super user with the permission to change user passwords, selects the option on the *Users Lookup* page to *Change Password*. The new change password page will allow an option to *Reset Via Email*. This option will send an email link to the user to reset their password. The link will expire if not acted on before the expiry time limit (system default of 60 minutes).






Choosing the option to *Reset Password Via Email* will email a *temporary link* to the user. The email is not actually changed at this point. The system is only generating a *temporary token* to allow the user to reset their password. If the user remembers their password, after selecting the reset via email link they can simply logon to the Online RMS using their password and then delete the email notification link. Successfully logging on to the Online RMS as the user requesting their password be changed via email, will automatically *delete / invalidate* the temporary token. The following is a screen capture of how the email and password reset link will appear to the user.







When clicking on the *reset link* in the email, the user will be required to enter their Online RMS user id and new password. Upon clicking *Submit*, the system verifies:

- The User Id matches the User ID for the temporary token that was generated
- The temporary token is still active
- The password and confirmation password match

If you are receiving this email in error, please contact your system administrator.

- The password contains only allowable characters
- The password follows the password history rules



If the temporary token does not exist or has expired, the user will see a message that the password reset token has expired.

Your password reset token has expired.


The user can choose the option again to reset their password via email or contact their agency administrator for password reset assistance. Once the password has been successfully changed the user can log in to the Online RMS.




IA-58460: Enhance Incident Security Work Groups Codes to Support default Exclusive Flag

Agencies utilizing *Incident Security Work Groups* can now configure a work group to automatically apply the *exclusive flag* when the Security Group is added to an Incident Report. This enhancement will alleviate the need for a user to check the *Restrict Access to Selected Security Groups* checkbox when adding a security group to an Incident Supplement or to a follow-up case, when the security group is identified as *Restricted / Exclusive*.

When adding a security group to an Incident Supplement or a follow-up investigative case, where the security group has been defined as *Enforce Exclusive Access*, the *Restrict Access to Selected Security Groups* checkbox will default to being checked and can't be unchecked. To uncheck the *Restrict Access to Selected Security Groups* checkbox the restricted security group will need to be removed from the Incident Supplement or follow-up investigative case.







IA-59425: Roles - Permissions are now listed in order when viewed

Administrative users will notice that *Permission categories* are now *ordered by description* when viewing the *Permission Categories* for a selected *role*.



EVIDENCE ENHANCEMENTS

IA-59889: Evidence – Auction Amount isn't known when property goes to auction


Evidence users will notice that the 'Auction' amount is no longer a required field when disposing of evidence as being 'Auctioned'. The 'Auction' field is now optional to support workflows where an evidence item is being auctioned, however the amount is not known at the time the disposition is entered.





IA-35145: EVIDENCE - Add Agency Name to New Evidence Barcode Label

Agency Admin users having permission to modify the agencies *evidence barcode label template* will now notice the option to include the *agency name* on the barcode. The new agency name label can be found in the *Available Fields* grid for selection.






TOW IMPOUND ENHANCEMENTS

IA-59426: Tow/Impound – Only Display Active Agencies in Agency LOV


Users of the *Tow / Impound* module in *multi-tiered agencies* or *multi-tenant sites* will notice the Impound Agency List Of Values (LOV) has been enhanced to only display Agencies that have *at least one active user* configured for the agency. This enhancement will improve usability by filtering the LOV to only display Agencies with active users.





IA-58794: Tow/Impound - Information not transferring from Field Arrest to Incident Report

Users utilizing the Online RMS Field Arrest module will now have the option to import *Tow / Impound* information entered on a Field Arrest when the Field Arrest is *associated to an incident report*. When selecting a Field Arrest to associate to an Incident Report or selecting the option to update the Incident Field Arrest association, users can select the option to transfer the Tow / Impound data to the Incident Report.





INTERFACE ENHANCEMENTS

IA-59832: Enhance Vehicle matching logic for import interfaces

An enhancement was implemented to support *multiple levels of matching criteria* for *interfaces that import vehicle* information into the Online RMS Master Vehicle index. Free text make and model descriptions from external systems is the main cause of duplicate vehicle indices, as the information does not match the expected codes or descriptions used within the Online RMS. This enhancement will help to reduce the number of duplicate master vehicle records created from external interfaces.

The new criteria for *Vehicle Matching* is as follows.

Criteria 1 - Match VIN

- Exact Match - Use the most recent Vehicle record that exists if more than one vehicle matches

Criteria 2 - License Plate #, Plate State, Vehicle Year, Make, and Model

- Exact Match - Use the most recent Vehicle record that exists if more than one vehicle matches.

Criteria 3 (Optional) - Uses license number, vehicle year, and make without the model. This option has been configured as disabled upon initial rollout of this enhancement. If a site is interested in adding this criteria, please contact Caliber Support Services by ticket or phone.

At this time, the matching criteria (1 & 2) have only been implemented for the *Indiana Statewide Aries (eCrash) and eCWS (Citation) interfaces*. For agencies outside of Indiana having external interfaces to systems that import vehicle records into the Online RMS, please contact Caliber Support Services by ticket or phone to request enabling the multiple levels of matching criteria.

IA-52455: RMS/CAD Interface-Handling Rescinded Cases/Incidents

The CAD to Online RMS interface can now be configured to **Not** create incident reports for case numbers received from CAD with a status indicating the case was '**cancelled'** or '**rescinded'**.

A new configuration setting for the CAD to Online RMS interface, INCIDENT_CANCEL_STATUS, indicates what status CAD sends to indicate a case # has been rescinded or cancelled (Interface Maintenance screen). This setting is defaulted to 'CANCELLED' for Caliber CAD NG but can be modified to different values for interfaces with other CAD service providers. If a case # is received with that status, the import will not create or update an incident report for that case #.

The import process will **NOT delete an existing incident report** from Online RMS that was previously created from a CAD spill prior to the Case # being rescinded / cancelled in CAD. Users will need to take action via the Online RMS to delete incident report that were spilled to the Online RMS prior to the Case # being rescinded / cancelled in CAD.



IA-57922: CAD to RMS – New Configuration option to not create RMS incident Report from CAD Run #'s


The CAD to Online RMS interface can now be configured to **Not** create incident reports in the Online RMS for specified types of CAD case / incident types. This enhancement was implemented to support situations where CAD is generating case #s for RMS incidents and run #s for traffic crash reports where the agencies are also entering the crash report # in the State Crash system that is spilling records to Online RMS. This functionality has a dependency on a CAD enhancement to include the report type in the XML tag <IncidentReportType> . The CAD enhancement is being tracked under JIRA IA-58755 and is target for a future release. Once implemented, agencies can contact Caliber Support via ticket or phone to request this option be enabled for their site.



INCIDENT REPORT ENHANCEMENTS

IA-59012: Incident Report - Changing Officer's Jurisdiction Changes Officer's Agency on Reports

This enhancement will improve and preserve agency information for users in *multi-tiered agencies* that are allowed to change their *home agency* from the user's manage profile page. When a user switches their *home agency*, a record will be created in the *officer's assigned history page* to archive the officer's prior *home agency*. From this point forward, incident reports and other RMS event records in the system that have an associated officer will reflect the agency information for the officer, at the time the officer was associated to the incident report or other RMS event record.








Users of the Online RMS Incident Based Reporting (IBR) Submission module will notice that warnings will no longer appear on the *Data Audit Warnings* tab for data situations that triggered audit warnings in prior supplements that have now been resolved in a new supplement. The *Data Audit Warnings* tab provides the opportunity for an agency to self-audit incident reports included in the data submission that may be at risk of a data audit by the IBR authority. Data audits represent data situations that are commonly flagged by IBR authorities as uncommon or overly used that should be evaluated by the agency prior to submission. The goal of this process is to ensure the quality and accuracy of data submitted to the IBR authority. The following warnings have been updated to be supplement friendly:


- 1. Incident contains a Hate Bias Motivation of Unknown. The state and federal IBR authorities will expect this to be updated as the investigation of an incident continues. Failure to update can trigger an audit in the future.
- 2. Incident contains a Hate Bias Motivation. Please verify that Hate/Bias was a factor in the incident.
- 3. Incident is classified as a simple assault with no weapons and minor injuries. Often, agencies will code hands/fists and feet as no weapon (None). Please verify that Personal weapons were or were not used to cause the injuries.
- 4. Aggravated Assault The victim of this incident of Aggravated assault sustained no injuries or only minor injuries. The weapon used was personal weapons. Please verify this was not a Simple assault.

Notifications sent to supplement reporting officers by IBR submission users are tracked on the *Warning Notification History* tab and will show the status of whether the warning has been resolved.









IA-59450: Review Routing - Add reviewing officer information to printed report

The Incident report approval process was enhanced in the prior release (10.25) to support a configurable multi-level routing process for reviewing approved incident reports. The enhancement implemented for this JIRA will now display the reviewing user's name on the printed incident report, in the *Officers Involved* section.
