Kansas only allows a victim / Suspect Child Record (AKA: DTVSUS) segment to be submitted for Crimes Against Persons and Robbery with a known offender. This fixed appropriately handles the generation of the DTVSUS segment.
IA-61859	N/A	RMS -> InfoExchange. Cache Search Results for Initial Tab Display	Performance	This JIRA improves the query performance of sites that have the new RMS InfoExchange query capability enabled.
IA-61863	N/A	Affidavit Report - Update to "AFFIDAVIT PREPARED BY ID #" to Officer name and badge #	Enhancement	This request updates the Mississippi Affidavit report to print the Officers First Initial, Last Name and badge #. As example: "T. Thompson #007" rather than a user's RMS login name.

Kansas deviates from the FBI NIBRS submission rules and validations for when not known (00) offender records can be submitted. (00) Not Known offender segments are not correctly submitted per the Kansas KIBRS specific rules.



IA-61881	344398	MO_IBRS - Group B Arrest, Segment 7 requires Incident No	Bug/Defect	State of Missouri IBRS data submission issue. Missouri IBRS differs from the FBI NIBRS submission and validations in that Missouri requires the incident report # for Group B offense arrests. Missouri IBRS submission process updated to include the incident report # segment for group B arrests.
IA-61901	N/A	Install script for release 10.27.2	Configuration	Script to update the release version number in Help file.
IA-61980	344398	MO-IBR Error F4-44-02 LEOKA Officer ORI Jurisdiction required	Bug/Defect	State of Kansas IBRS data submission issue. Kansas deviates from the FBI NIBRS submission rules and validations in that a Jurisdiction ORI is required to be submitted for Officer assaults (LEOKA) regardless if the officer is from the jurisdiction reporting the crime. NIBRS only requires Officer Jurisdiction ORI if the officer is from a different agency that reported the crime. The Officers ORI will now automatically be defaulted in the submission file when not specified as an officer from another agency.
IA-62077	347536	Incident Report – Add and edit flow of a Person to Incident Report issue	Bug/Defect	Fixed a workflow issue when taking action to select and edit an existing person from Master Name Index, to add to an incident report caused the workflow to terminate.
