

The multi-match person logic was enhanced to handle situations where more than one RMS master person (Duplicate) is returned for the comparison against the external person data. The previous logic created a new person record if more than one match was found. The enhancement will support configuration for using the oldest or most recent master person name.



Incident security for viewing external involvements for Master Name Person searches will now be enforced as follows for the supplement the person is listed on: - Must not be agency only - Must not have an exclusive security/workgroup - Security level must be less than or equal to the maintenance value INCIDENT_XML_SECURITY_EXPORT (set to officer level by default).
IA-63093	352577	Field Contacts - Unable to change security on field contacts	Bug/Defect	Resolved and issue where a user is unable to change the security level on a field contact.
IA-63108	352600	Collapse - Collapsed Person Record displays no data	Bug/Defect	Resolved an issue where previously collapsed names were not displaying in the collapse log if the user id was the System user. Collapse names will now display regardless of the collapsed by user. Functionality note. Alias names can be deleted from a collapsed person record if the alias name was not linked to a prior event. If an alias name was manually deleted after a collapse the name will no longer display in the collapse log.
