Evidence Module Refresh and Enhancements

A modern look and feel and numerous enhancements to the Evidence Management module provides improved usability and efficiency for officers and evidence custodians. A few highlights; Place Check-Out Property in temporary storage as Pending Check-In when returning from lab, log Extend Chain-Of-Custody for evidence that is checked out and checked back in, capture Recovered and Placed Into Evidence date/time. 


Figure 4: Online RMS CFS View Page with New Vehicle Grid




Figure 5: Address Collapse Search Duplicates



NIBRS Offense Assist

To improve the accuracy of offenses selected by officers and the review of Incident reports by Supervisors and Clerical staff the Incident Offense displays now include details for the related NIBRS Offense code, NIBRS Offense Title, and a detailed offense description. Displaying this information during the Offense entry and Supervisory Approval process ensures the accuracy of offenses included on an incident report. Enhancements include:

- 1) The capability for System Administrators to enter a NIBRS crime description for each NIBRS Offense and/or a crime description for each State Offense.
- 2) The capability to view the Offense crime description or the NIBRS crime description when selecting an offense on an incident report, editing an incident offense, or viewing incident offenses.
- 3) The capability to view the Offense crime description or NIBRS crime description when viewing the Offense Glossary.
- 4) A quick view Tab option on the Incident Approval page to streamline the review of information contributed on the supplement report being approved.
- 5) A quick view Tab option on the Incident Approval page to open the Offense Glossary lookup feature. Supervisors can use this new offense lookup feature to verify the appropriate offense is on an incident report.




Figure 6: Incident Approval - New Incident Review Tab with NIBRS Offense Assist and Offense Glossary Tab

Fillable PDFs

Additional person details are now available to include on fillable PDFs integrated with Custom Form. The capability to include additional person information will provide greater flexibility and empowerment to agencies using Custom Forms to prepare agency specific letters/print-outs.




Figure 8: Fillable PDFs - Available Person Details




Figure 10: BroadCast Message - Add Attachments

InterDEx Import and Awareness

For sites participating in Caliber's InterDEx sharing network, reduced data re-entry by importing an InterDEx person, vehicle, or property record if the record does not exist in Online RMS. In addition, an enhancement to improve the automation of InterDEx person search queries on the Person Details page by using a progressive relaxation search feature. The new search feature automatically searches InterDEx by Name/DOB, then SSN, then DLN and combines the results to ensure maximum awareness of information from over 300+ InterDEx data sources. Person Juvenile Warning

Reduced data entry and awareness of Juveniles using alert text on the Person Details edit and view pages. Enhanced the Online RMS for awareness when creating or working with Juvenile Master Name records. The following enhancements are available:

- 1) Display a verification message to the user if entering a DOB where the person is a Juvenile or older the 100 years of age.
- 2) Add an alert on the Person Edit, View pages, and Summary Pages, that Displays "JUVENILE" if the person is a juvenile (based on DOB and system date).
- 3) On the person search results and other pages where the person caution triangle displays, include a warning for Juvenile if the person is a juvenile (based on DOB and system date).
- 4) When printing the person details report, print the wording of Juvenile in Red Text if the person is a juvenile (based on DOB and system date).




Figure 14: Create Person - Juvenile Warning


