## ONLINE RMS 10.30 HIGHLIGHTS

Online RMS 10.30.0 includes many new updates, based on clients' feedback. The overall release focus is to increase productivity and provide an updated user experience. ***Please see the updated Online RMS User and Admin Help files for more details on the enhancements and features highlighted in this release bulletin.***

### Personnel Management

Manage and track all departmental personnel regardless of whether employees have a user account to the Online RMS. Capture Service History, Education, Languages, Skills, Classifications, Affiliations, Addresses, Employee Contacts, Phone Numbers, Medical Info, Other Info, Groups, Attachments, and Identification for all employees. A dedicated search page supports a central search to find, view, and manage employee records. Personnel Management is a new feature that is granted to all agencies as a standard feature for this release. Three new permission categories to manage personnel at the Schema/System level, Organization/Multi-tier Agency level, or Agency level are available to assign to Roles as desired. The permissions have been assigned accordingly to the System\_Admin, Organization\_Admin, and Agency Admin Roles for initial release.




Figure 1: Personnel Management Search Page – Records Management Menu -> Personnel Management










Figure 8: Incident Search – Additional Search Criteria - Officer List of Values (Active/Inactive Designator)









## CFS Search




