Fleet Management Enhancements

Enhancements to the Fleet Management dashboard include PDF and Excel export, a new Agency drop down, and display of Unit#. When users are part of a multi-agency tiered configuration an 'All Agencies' filter has been added to the Agency search option of fleet vehicle search enabling a search for all agencies within the user's organization. After viewing a specific unit and using the "Back" button the Agency search criteria is retained. The Vehicle Id column was replaced with "Unit #". If a vehicle has a unit #, the unit # will display. Otherwise the Vehicle ID will display. A new column for vehicle status was added to all three of the fleet manager dashboards

The capability to restrict the assignment of vehicle categories by role allows agencies to control what user can search and find vehicle categories. This enhancement provides security for special assignment and/or confidential unit vehicles. The Category to Role association defines vehicle categories (and the vehicles themselves) that can only be accessed by users with particular roles.

Evidence Enhancements

Evidence "Quick Pending Check-in" has been enhanced to allow extended chain of custody entries with comments. More than one evidence ID can be entered during the check-in with sub-rows for each custody event. When the entry is saved, the evidence items will be placed into "Pending Check-in" with the additional chain of custody items saved as "Custody Comment" entries.

The initial roll-out of this capability will include searching for people, vehicles, locations, and phones. Future updates will increase user efficiencies and reduce time by allowing users to import public record data to create or update master indices records in Online RMS. A control mechanism exists to control if the search is automatically performed or not.

Security Enhancement / TLS 1.2 Protocol

Industry best practice recommends the depreciation of TLS 1.0 and TLS 1.1 as both protocols are known to have vulnerabilities. TLS 1.2 is the industry recommended secure encryption protocol for protecting online data transactions. The Online RMS 10.31 release is prohibiting and removing the use of vulnerable encryption protocols, specifically TLS v1.0 and TLS v1.1. Only the TLS v1.2 protocol will be allowed with Online RMS 10.31.
