### Follow-up Investigative Case Management Improvements

Enhancements to the Case Management module **streamline usability**, offer **improved management** of cases, and **provide awareness** to assigned users of upcoming and overdue case activities.

- Instant awareness of **upcoming and overdue case activity** from Home Page – Recent Activities.
  - Open Activity Count – Displays as “**Red**” = One or more case activities are overdue.
  - Open Activity Count – Displays as “**Yellow**” = One or more case activities are coming due.

## Remote Geo-Coordinate Mapping and Address Search Improvements

For events occurring at locations that are not at a specific address, users can drag the **Map Marker**  to a location on the map to use Geo-Coordinates for that location. The Address search results page includes a Geo-Verified Indicator for awareness of addresses that are Geo Verified. One-line search enhanced to include State and Zip codes. New Search option for searching by Latitude and Longitude and radius

- Dynamic Map Marker – Choose a result from the location **Matches Found** and then drag the Map Marker to the exact location on the map to update Geo-Coordinates for the Master Location record.

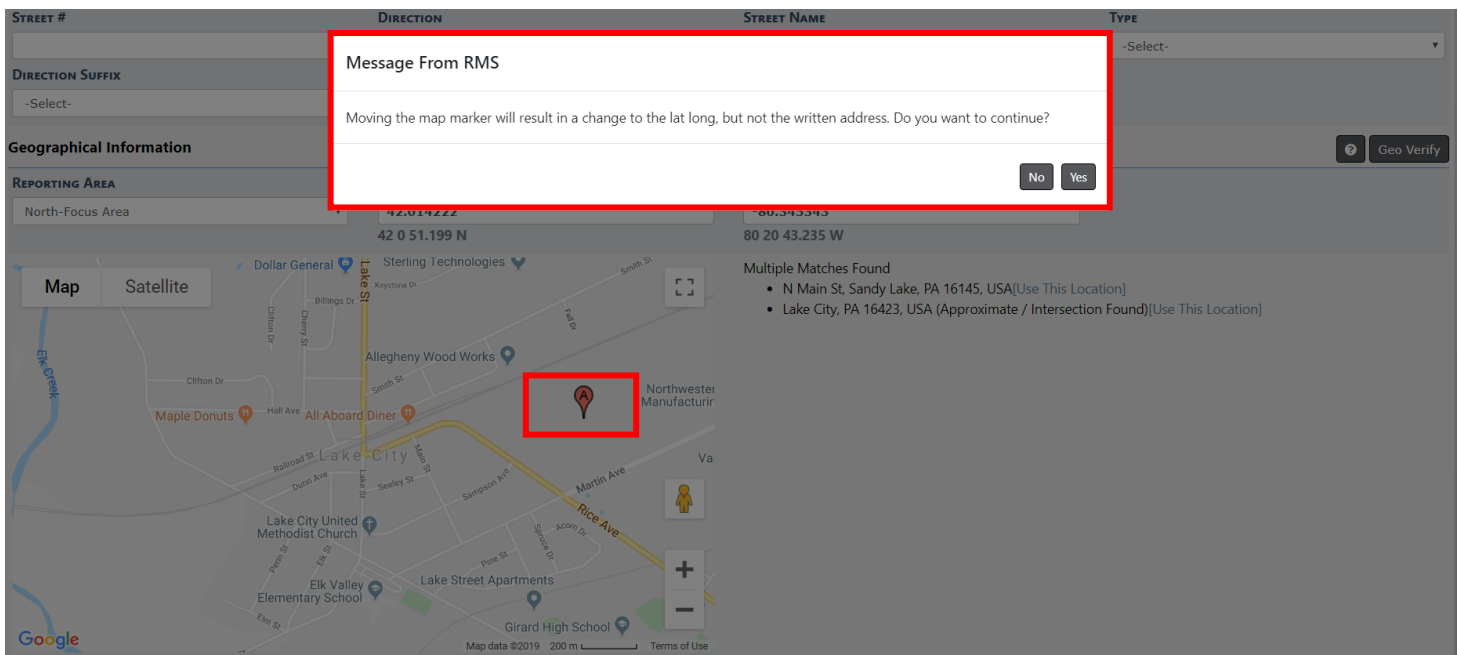


Figure 18: Edit Address – Drag Map Marker to update Geo-Coordinates

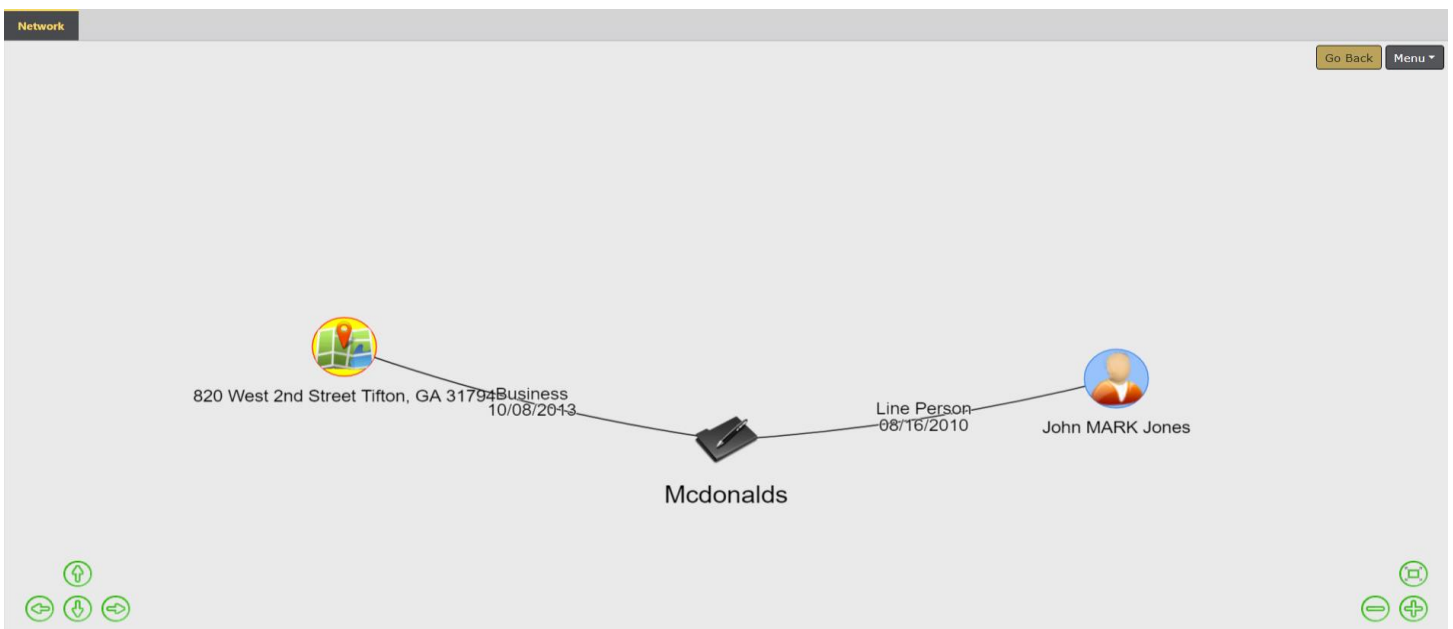


Figure 27: Visualization Tool for Organizations/Businesses

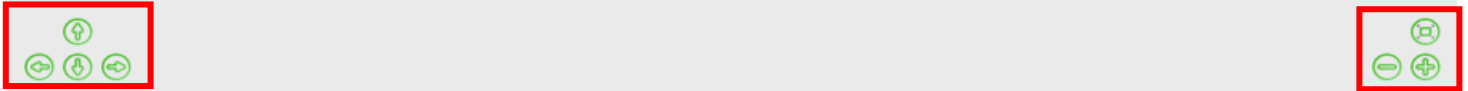


Figure 28: Visualization Interactive Icons
